



Advanced Standing Agreement
Between
Hussian College
And
Eastern Center for Arts and Technology

This agreement is made this 15th day of May, by and between Hussian College ("HC") and EASTERN CENTER FOR ARTS AND TECHNOLOGY ("ECAT").

WHEREAS, EASTERN is a secondary school offering a program in Commercial Art (CIP 50.0402) ("ECAT").

WHEREAS, HC is an institution of postsecondary education offering a Bachelor of Fine Arts degree program in Art (CIP 50.0402) ("HC Program"), is located in Philadelphia, Pennsylvania, and is accredited by the Accrediting Commission of Career Schools and Colleges;

WHEREAS, the parties desire and intend to set forth the terms and conditions of under which HC will provide ECAT students who have completed the ECAT Program with advanced standing in the HC Program; and

WHEREAS, the parties desire to reduce their agreement and understandings to writing;

NOW THEREFORE, in consideration of the foregoing premises the parties agree as follows:

HC agrees that ECAT students successfully completing the ECAT Program and who meet the following requirements (an "Eligible Student") shall be eligible to receive up to 21 credit hours articulated into the HC Program:

1. Has successfully completed the ECAT Program (Graphic Design, Commercial Art, or Image Finder)
2. Is in good academic standing with ECAT;
3. Is not subject to any ECAT disciplinary or behavioral proceedings;
4. Has a personal interview with HC Official on ECAT Campus; and
5. Meets all HC Program admissions requirements

Eligible Students must seek admission and enroll in the HC Program within 2 years of high school graduation.



Transfer Credit will be transcribed for the following tracks as:

<i>Graphic Design</i>	<i>21 credits</i>
<i>Commercial Illustration</i>	<i>18 credits</i>
<i>Image Finder</i>	<i>9 credits</i>

The HC Review Committee can award up to 21 semester credits based on the competencies falling under CIP 50.40. HC awards credit based only off of the HC Review Committee's recommendations. HC does not provide credit for NOTCI or Adobe Certification. In unlikely circumstances, the President of HC can override the Review Committee's recommendations.

HC and ECAT agree to provide prior notice to the other regarding any changes to the HC Program or ECAT Program curriculum. HC and ECAT shall each have a right to terminate the Agreement in the event of a material change to the HC Program or ECAT Program, respectively.

This Agreement constitutes the entire agreement between the parties, and all prior discussions, agreements, and understandings, whether verbal or in writing, is hereby merged into this Agreement.

No amendment or modification of this Agreement, including any amendment or modification of this paragraph, shall be effective unless the same is in writing signed by both parties.

This agreement expires on June 30, 2020.


